



## **RELEASE OF LIABILITY AGREEMENT**

This Release of Liability Agreement ("Agreement") is made and entered into as of Registration date as per the form filled by and between Woxsen Sports Academy, with its principal place of business at Kamkole, Sadasivpet, Sangareddy District, Hyderabad, Telangana – 502345, India (hereinafter referred to as "Woxsen"), and Online registered candidate [Participant Name], residing at Woxsen University (hereinafter referred to as "Participant").

### **WITNESSETH**

WHEREAS, Woxsen provides access to its sports training facilities (the "Facilities") for independent athletes to train and develop their skills; and

WHEREAS, Participant desires to utilize the Facilities for his/her own training purposes;

NOW, THEREFORE, in consideration of the opportunity to utilize the Facilities, the Parties agree as follows:

### **1. Release of Liability**

1.1. In consideration of being permitted to utilize the Facilities, Participant hereby assumes full responsibility for any and all risks of injury, illness, death, or property damage arising out of, or in any way connected with, Participant's use of the Facilities.

1.2. To the fullest extent permitted by law, Participant hereby releases, waives, discharges, and covenants not to sue Woxsen, its officers, directors, employees, agents, volunteers, successors, and assigns (collectively, the "Released Parties") from any and all claims, demands, losses, liabilities, or causes of action of any kind whatsoever (collectively, "Claims") arising out of, or in any way connected with, Participant's use of the Facilities. This release includes, but is not limited to, Claims for:

- Personal injury, illness, or death;
- Property damage;
- Emotional distress; and
- Any other loss or damage of any kind whatsoever.

1.3. Participant further agrees to indemnify, defend, and hold harmless the Released Parties from and against any and all Claims, losses, damages, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of, or in any way connected with, Participant's use of the Facilities.

### **2. Financial Responsibility for Property Damage**

2.1. In addition to the foregoing release of liability, the Participant agrees to be financially responsible for any property damage caused by his/her use of the Facilities, including but not limited to damage to equipment, buildings, or grounds.

2.2. Participant agrees to reimburse Woxsen for the full cost of repair or replacement of any property damaged by Participant, as determined by Woxsen in its sole discretion.

### **3. Medical Clearance**

3.1. Participant warrants and represents that he/she is in good health and has obtained a medical clearance from a licensed physician authorizing participation in athletic activities.

3.2. Participant agrees to provide Woxsen with a copy of the medical clearance upon request. Woxsen reserves the right to deny access to the Facilities to any Participant who does not provide a current medical clearance.

3.3. Participant further agrees to notify Woxsen immediately of any changes in his/her health condition that may affect his/her ability to safely use the Facilities.

### **4. Rules and Regulations**

4.1. Participant agrees to abide by all rules, regulations, and safety instructions established by Woxsen for the use of the Facilities. These rules may be posted at the Facilities or provided to Participants separately. Woxsen reserves the right to remove the Participant from the Facilities for any violation of these rules or for any conduct that Woxsen deems to be disruptive or unsafe.

4.2. Participant acknowledges that he/she is solely responsible for bringing and using all necessary equipment for his/her training.

4.3. Participant agrees to use the Facilities in a safe and responsible manner and to avoid any actions that could damage the Facilities or injure himself/herself or others.

### **5. Governing Law**

5.1. This Agreement shall be governed by and construed in accordance with the laws of the State of Telangana, India, without regard to its conflict of laws principles.

### **6. Entire Agreement**

6.1. This Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.
